

# ENVIRONMENTAL MANAGEMENT GRADUATE AND SHORT COURSES



The ANU now offers its program both in Canberra and in Melbourne at its premises in Collins Street. The program is offered so that part-time students will be able to complete a Graduate Certificate in Environmental Law in one or two semesters and a Graduate Diploma or Masters in two years. Individual subjects may also be done as short courses ideal for professionals who wish to update their knowledge in a specific area without doing any assessment.

The program is designed for those with no legal background, whether planners or policy makers, environmental managers or consultants, as well as for lawyers. Its aim is not only to provide students with a sophisticated understanding of key areas of environmental law but also to explore the law's origins and implementations, strengths and weaknesses.

Each course can be undertaken as either a "Short Course" or a "Graduate Course". Professional Development Short Course - Professionals who wish to update knowledge in a specific area. A short course participant does not complete any assessment (a certificate of completion is issued). A short course cannot be used towards a graduate program.

**Graduate Degree Course** - Enrolled students (including cross-institutional and non-award study). Students complete assessment and courses contribute towards postgraduate programs eg Masters, Graduate Diploma or Graduate Certificate.

## **Professional Development Short Course fees in 2010**

\$1,800 for a 6 unit course

## **Graduate Degree Course fees in 2010**

\$2,250 for a 6 unit course (for domestic students)

Masters degrees require courses totalling 48 units

Graduate diplomas require courses totalling 36 units

Graduate certificate requires courses totalling 24 units
