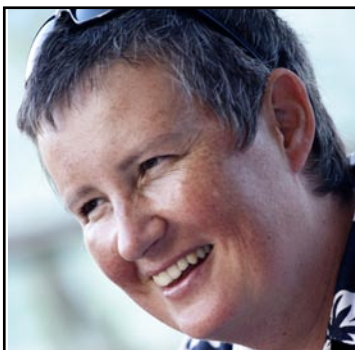

The College has made appointments at all levels. Introducing an innovative scheme for early career academics, the College has appointed three Teaching Fellows, who will enjoy all the benefits of an ongoing academic staff appointment, but with a reduced teaching load in order to enable them to pursue a PhD.

The Teaching Fellows are **Brad Jessup**, a Monash University law graduate currently studying environmental law at Cambridge University; **Wendy Kukulies-Smith**, an ANU law graduate and criminal lawyer; and **Helen Saunders**, a Sydney University law graduate and commercial lawyer.

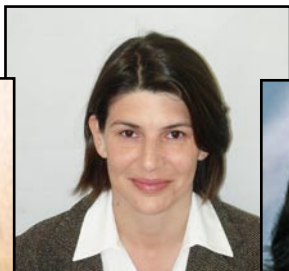

The other appointments cover a wide range of areas and expertise. **Samantha Hepburn**, currently at Deakin University, is one of Australia's leading property lawyers, with particular expertise in native title law, equity and trusts. **Molly O'Brien**, a US lawyer currently at Wollongong University, brings impressive practical and academic experience in evidence, litigation, trial advocacy and criminal law. **Kath Hall**, recently returned from working with AusAID in Indonesia, has special expertise in corporate law and Chinese law, and a special interest in the psychology of corporate governance. **Sarah Heathcote** adds even greater strength to the College's renowned expertise in international law, having obtained her PhD and taught for the past decade at the University of Geneva. And **Lauren Honcope**, formerly a senior lawyer with the Australian Government Solicitor in Canberra, joins the ANU College of Law's Legal Workshop to teach civil practice.
