In particular, I use case studies with "bottom-up" perspectives of individuals & communities in global aid agendas, with findings that drive interventions that demonstrate the prevalence of rule-of-law concerns in prevailing social science theories. In order to do this, I publish across a range of areas to show how rule-of-law problems permeate & challenge a breadth of social science perspectives on international issues. My publications have made interventions in areas of Law & Development, Human Rights, Environment, International Relations, Comparative Law, & International Law. I make unique contributions to global levels of scholarship by drawing upon my experiences as advisor to international aid programs in developing countries of Southeast Asia & as an Indigenous scholar with a multi-cultural & multi-disciplinary background sensitive to the grass-roots complexities challenging international aid agendas.
