Students who hold an overseas law degree are normally required to do at least one of these fundamentals courses at the beginning of their program.
- > Prerequisites vary depending on the program you are studying. Please check the course prerequisite statement and your program requirements on ANU Programs and Courses before you enrol.
- > Students in the JD on-campus must have completed or be completing 5 x 6100 level courses prior to enrolling in any Masters electives. Students in the JD online must have completed LAWS8712 prior to enrolling in any Masters electives. JD students can choose any electives except those noted under Specialisation(s).
- > Graduation: please note that courses scheduled in late Autumn are not guaranteed to have results in time for July graduation. Courses held in late Winter and Spring sessions are not guaranteed to have results processed in time for the December graduation ceremony.
